

MS Toxicology FAQ

1. Q: What is the application deadline for the Toxicology M.S. Program?

A: The application deadline for international applicants is January 15th. There is a rolling admissions process for domestic students. We suggest April 15th for best consideration.

2. Q: Do you accept applications for Spring admission?

A: No, students are only accepted for Fall semester admission.

3. Q: How do I apply online?

4. Q: I am experiencing problems with the online application. Who should I contact?

5. Q: Is there an application fee and how many programs can I apply to with one fee?

A: Yes, there is a \$75.00 (U.S.) application fee paid to the Graduate School. You may apply to one GPILS program per \$75 application fee. You may only apply for 2 programs total.

6. Q: How many students do you accept each year?

A: The M.S. program does not offer a stipend and therefore does not limit the number of students accepted. Offers are based on the number of qualified applications received.

7. Q: What is the average GRE score for students accepted into the Cellular and Molecular Biomedical Science M.S. program?

A: The average GRE scores for the 2017 incoming class were 150 Q, 150 V, and 4.0 A.

8. Q: What if my GRE scores are lower than the average?

A: All aspects of the application will be taken into consideration (i.e. GPA, personal statement, transcript(s) of all college coursework, and letters of recommendation). Prior research experience is encouraged. Applicants must show evidence of coursework in life sciences with a grade of B or above, based on a U.S. standard grading scale.

9. Q: Will the program accept my MCAT scores in lieu of the GRE?

A: Yes. We will accept MCAT scores.

10. Q: Are applicants required to take the GRE Subject Test?

A: No, GRE Subject Test scores are not required, and will neither hinder nor aid in an applicant's chances for admission.

11. Q: Do you offer financial aid?

A: Funding is not provided for students admitted into the M.S. program. Financial Aid may be available through the Student Financial Aid office. Please visit their website <http://www.umaryland.edu/fin/>. Also, after the first semester, some of the M.S. students seek employment opportunities in faculty laboratories on campus, which in some cases may provide tuition assistance. Job search assistance will not be provided.

12. Q: Do you accept international students?

A: Yes, we accept international students. Assistance for international students can be found at <http://www.umaryland.edu/ois/>

13. Q: Is there financial aid available for international students?

A: Funding is not provided for students admitted into the M.S. program and a student must be a citizen or eligible noncitizen to receive federal, state and/or institutional aid at UMB. 14. Q: If I am an international student with a B.S. degree from a U.S. university do I need to take the TOEFL?

A: The TOEFL requirement is waived for applicants who have received a B.A/B.S degree from an American accredited university/college.

15. Q: What is the average TOEFL score for students accepted into the Toxicology M.S. program?

A: The average TOEFL score for the 2015 accepted students was 106.

16. Q: Do you accept the IELTS exam in place of the TOEFL exam for International applicants?

A: Yes, but we will only accept an IELTS score of 7 or higher.

17. Q: What is the institution code for reporting GRE & TOEFL scores?

A: GRE scores: Institution code 5848; program code 0206 TOEFL scores: University code 5944; department code 45

18. Q: Where do I send my letters of recommendation?
